Hope for the Children of Haiti provided healthy meals and living conditions, medical care and educatin to close to 100 Haitian children under guardianship. As children whom were malnourished and exposed to emotional and physical trauma, evaluation of many physical and emotional needs were provided and special needs resources identified. Beyond those under our guardianship, we provided education opportunities and mentoring to about 400 additional children in the surrounding community of Bolosse in Port-au-Prince. About 15 of the 60 first generation young adults raised at the HFC are being supported in their transition into See Part III, Ln 4a statement

HFC provided opportunity for over 80 caring individuals and institutions to volunteer personal time and skills and make a difference in the lives of Haitian children. Education, medical, and technical support & other services including facility repairs and maintenance are provided as their missions trips to Haiti and the Hope for the Children of Haiti

As mentioned, HFC provides K through High School education to the children of the surrounding neighborhood of Bolosse in Port-au-Prince. We provide free nutritional meals to the students and the staff as a supplemental program to improve the overall health of the Haitians in the community.
